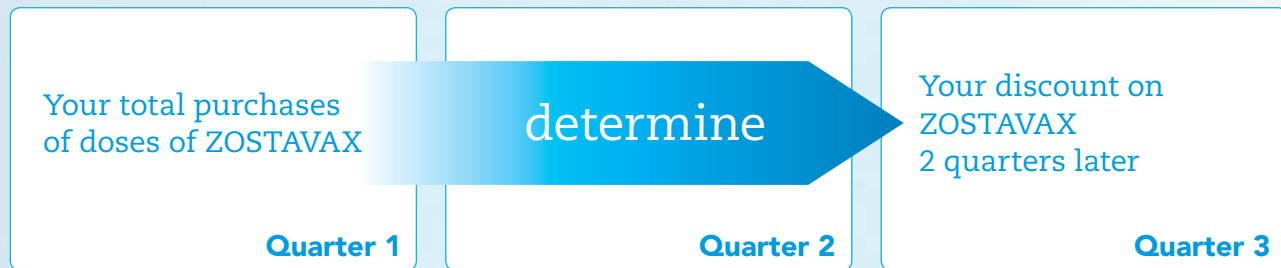
Highlights of Eligibility Requirements

 - Retail Pharmacy locations enrolled must have the ability to adjudicate the following claims for eligible patients at the time ZOSTAVAX is administered to the patient via the retail pharmacy's computer system
 - Medicare Part D claims
 - AND**
 - Claims for at least two of the following benefit plans: TRICARE, Federal Employee Benefit Plan (FEP), Commercial Plans with a Managed Care Organization or through a Pharmacy Benefit Manager (PBM).
- ▶ To be eligible for discounts on PNEUMOVAX®23 (Pneumococcal Vaccine Polyvalent):
 - Retail Pharmacy locations enrolled must have the ability to adjudicate the following claims for eligible patients at the time PNEUMOVAX 23 is administered to the patient via the retail pharmacy's computer system
 - Medicare Part B claims
 - AND**
 - Claims for at least one of the following benefit plans: TRICARE, Federal Employee Benefit Plan (FEP), Commercial Plans with a Managed Care Organization or through a Pharmacy Benefit Manager (PBM).

Simply purchase ZOSTAVAX based on *your needs* during the quarter

Your purchases of ZOSTAVAX will be aggregated to determine the Tier level (e.g. Base, Tier 1 or Tier 2) and associated on-invoice discount for ZOSTAVAX *2 quarters later*
